## **TISSOT BUZZER BEATER SWEEPSTAKES 2025-2026**

## OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. The Tissot Buzzer Beater Sweepstakes ("Sweepstakes") is sponsored by The Swatch Group (U.S.) Inc., Tissot Division ("Sponsor"), 800 Waterford Way, Suite 1000, Miami, FL 33126 and is administered by PROMOSIS, Inc., ("Administrator" or "Promosis"), 89 Front Street, Suite 205, Marblehead, MA 01945.

## 1. Sweepstakes Period:

The First Prize sweepstakes period begins at 12:00:00 a.m. ET on December 1, 2025 (the start of regular NBA season) and ends at 11:59:59 p.m. ET on October 20, 2026 (the anticipated end of the WNBA Finals)("Sweepstakes Period").

The NBA sweepstakes period will be open from 12:00:01 A.M ET on December 1, 2025 to 11:59:59 A.M. ET on April 13<sup>th</sup>, 2026 ("Sweepstakes Period").

The WNBA sweepstakes period will be open from 12:00:01 A.M ET on May 15, 2026 to 11:59:59 A.M. ET on September 12<sup>th</sup>, 2026 (the "Sweepstakes Period").

For purposes of the Sweepstakes, the sole determinant of the current time will be the clock on the promotion website server, regardless of what any other timekeeping device might indicate.

- 2. Eligibility: The Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Not open to employees and their families (spouses, parents, children/siblings and their respective spouses, and those living in the same household) of The Swatch Group (U.S.) Inc., Tissot Division, Wasserman Media Group, LLC, NBA Properties, Inc., the National Basketball Association (the "NBA") and its member teams (collectively, the "NBA Entities"), WNBA Enterprises, LLC, the Women's National Basketball Association (the "WNBA") and its member teams (collectively, the "WNBA Entities"), their subsidiaries, affiliates, participating retailers, promotion partners, advertising and production agencies, and Promosis, Inc. All federal, state, and local laws apply. Void where prohibited or restricted by law. By submitting an entry, the participant consents to the use of his/her registration information in accordance with the Sponsor's privacy policy. Entrants agree to the release of their name, address, and email information to Promosis for winner notification purposes and for public winner disclosure as required by law. Participation constitutes the entrant's full and unconditional agreement to the Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Entries must be complete to be eligible. Providing invalid information of any kind or otherwise failing to abide by these Official Rules will result in Sweepstakes disqualification. Entries must be received by 11:59:59 p.m. ET on April 13, 2026 for the NBA drawing and 11:59:59 p.m. ET on September 12, 2026 for WNBA drawing and <a href="https://doi.org/11.59/11.59/11.59/">https://doi.org/11.59/</a>:59 p.m. ET on October 20, 2026 for First Prize drawings. In the event of a dispute regarding the identity of any entrant, the entry will be deemed made by the person identified as the authorized account holder of the email address submitted at the time of entry (i.e., the natural person who is assigned to an email address by an

Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address). These dates are subject to change pursuant to the NBA/WNBA games schedule.

Submit an online registration within 24 hours of a qualifying Buzzer Beater event to receive one (1) bonus entry.

4. **Drawings**: During the Sweepstakes Period, there will be one (1) First Prize drawing corresponding to each of the first ten (10) "Buzzer Beaters" to occur during an official NBA regular season or postseason game, and the first ten (10) "Buzzer Beaters" to occur during an official WNBA regular season or postseason game. For purposes of this Sweepstakes, a "Buzzer Beater" is defined as when an NBA or WNBA player shoots and scores a basket right at the end of the game or at the buzzer. First Prize drawings will be conducted by Sponsor approximately three (3) days following the "Buzzer Beater", from among all cumulative eligible entries received. Potential First Prize winners will be notified via email by Sponsor, for winner eligibility verification. Sponsor will make all final determinations if or when a "Buzzer Beater" has occurred. If, in the sole opinion of Sponsor, fewer than ten (10) or no NBA "Buzzer Beaters" or fewer than ten (10) or no WNBA "Buzzer Beaters" occur during the Sweepstakes Period, those prizes will not be awarded.

Grand Prize drawings will be conducted from among all cumulative eligible entries received in each of two (2) Grand Prize Entry Periods, with the following deadlines: 11:59:59 p.m. ET April 13, 2026 (NBA Finals Grand Prize); and 11:59:59 p.m. ET September 12, 2026 (WNBA Finals Grand Prize). Grand Prize drawings will be conducted approximately three (3) days after the conclusion of each Grand Prize Entry Period. Potential Grand Prize winners will be notified via email from Promosis, and will be required to complete an online winner verification within three (3) days of the date of the email notification, or the prize will be forfeited. Potential Grand Prize winners will be required to upload a "selfie" photo and image of a government-issued photo ID, plus provide their Social Security number for IRS 1099-MISC tax form purposes, as part of the online verification. Grand Prize winners will be required to complete and return follow-up documentation sent via email from Promosis. Any potential winner who fails to respond to the winner notification, declines to accept a prize, or is found to be ineligible will be disqualified, and an alternate winner will be randomly selected from the remaining pool of entries received for the applicable drawing, time permitting, as determined by Sponsor in its sole discretion.

Approximate retail value = \$5,000.

WNBA Finals Grand Prize: a trip for two (2) to one (1) game of the 2026 WNBA Championship Finals (date and location TBD), to be scheduled at Sponsor's discretion, including round trip economy air travel from the major U.S. airport nearest the winner's home, three (3) nights hotel accommodations (1 room, dbl. occupancy), two (2) tickets to the game, a \$500 Gift Voucher for food & ground transportation and a Seastar Wilson WNBA 40mm Quartz watch. Approximate retail value = \$5,000.

Twenty (20) First Prizes (one (1) winner per each "Buzzer Beater" First Prize drawing): the

First Prizes will be comprised of a Tissot watch, signed NBA memorabilia, or similar items, of which the Total Approximate Retail Value (ARV) will not exceed \$600.00. Actual items will be selected at the Sponsor's discretion.

Actual value of Grand Prizes may vary based on timing of trip, location of departure city, and assessment of prize elements publicly available. Difference between actual value and stated value, if any, will not be awarded in cash or other consideration. Grand Prize trip dates will be scheduled by Sponsor.
