## TISSOT X LOS ANGELES LAKERS SWEEPSTAKES OFFICIAL RULES

## NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE.

These terms and conditions ("the Rules") govern the **Tissot x Los Angeles Lakers Sweepstakes** which is administered by The Swatch Group (U.S.) Inc., Tissot Division, 800 Waterford Way, Suite 1000, Miami, FL 33126 ("Tissot", "us", "our", "we"). By participating in this Sweepstakes, you agree to these Rules and to abide by them.

- 1. SWEEPSTAKES PERIOD: The Sweepstakes begins on June 2, 2025 at 12:00:01 AM Pacific Time ("PDT") and ends on June 30, 2025 at 11:59:59 PM PDT ("Sweepstakes Period"). Sponsor's server and computer clock is the official time-keeping device.
- 2. ELIGIBILITY: Entry is open to any legal resident of the state of California, excluding those areas that are within a 75-mile radius of the city of Sacramento and a 75-mile radius of the city of San Francisco, and aged 18 or over at the start of the Sweepstakes. This Sweepstakes is not open to employees and officers of Tissot, The Los Angeles Lakers, Inc. ("Lakers"), NBA Properties, Inc., the National Basketball Association (the "NBA"), and the NBA member teams (collectively, the "NBA Entities"), or any of their respective affiliates, agents, advertising, promotion or production agencies or any other entity involved in the development, production, implementation, administration, judging or fulfillment of the Sweepstakes (collectively, the "Sweepstakes Entities"), or the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) as such individuals not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.
- 3. HOW TO ENTER THE SWEEPSTAKES: During the Sweepstakes Period, an eligible entrant may complete and submit the registration form located online at <a href="https://cloud.communication.tissotwatches.com/los-angeles-lakers-sweepstakes">https://cloud.communication.tissotwatches.com/los-angeles-lakers-sweepstakes</a> including but not limited to his/her complete first and last name (no initials), valid e-mail address with zip code and phone number. By registering to participate via this method of entry, eligible entrants are agreeing to providing his/her registration information to both Tissot and Lakers in accordance with the terms and conditions set forth in the Privacy section below. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.
  - **3.1 ENTRY LIMIT**: There is a limit of one (1) entry per person during the Sweepstakes Period. If more than one (1) entry is received from the same person, telephone number and/or e-mail address the entries may, in Tissot's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Tissot's sole discretion, may not be eligible to win a prize.
  - **3.2 IMPORTANT:** MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. All mail entries must be received by June 30, 2025 at 11:59:59 PM PDT.
- **4. RANDOM DRAWING:** Tissot will randomly select one (1) potential winner (the "Winner") on or about July 2, 2025 pending verification of his/her eligibility and compliance with these Official Rules.
- 5. PRIZE, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:
  - **a. Prize:** The Winner will receive the following prize package (the "Prize"):
    - i. One (1) Tissot Supersport Chrono Basketball edition watch; and

- ii. Two (2) single-game tickets to one Los Angeles Lakers regular season home game during the 2025-2026 NBA season (the "Game") at Crypto.com Arena in Los Angeles, California (the "Arena"), with the actual game and seat locations to be selected by Tissot in its sole discretion; and
- iii. One (1) player-autographed jersey to be determined by Tissot in its sole discretion.
- b. ARV: Total Prize Approximate Retail Value (ARV): \$1,575
- **c. Odds of Winning:** The odds of winning the Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

The stated ARV of the Prize reflects unautographed merchandise. The ARV of hand-signed merchandise is subject to fluctuation based on the featured NBA player and current market value at the time such prize is awarded.

The Winner is strictly prohibited from selling the Prize.

6. HOW TO CLAIM A PRIZE: After the random drawing, Tissot will notify the Winner via e-mail at the e-mail address provided at the time of registration. If the Winner cannot be reached or does not reply within 48 hours of the prize notification, the Prize will be assumed to have been forfeited. The Winner may be subject to a background check before the prize is awarded. Tissot reserves the right to disgualify the Winner based on the results of such background check if Tissot determines in its sole discretion that awarding the Prize to any such individual might reflect negatively on Tissot or any other Sweepstakes Entities. Failure to provide all required information within the stated time period may result in forfeiture of the Winner's right to claim his/her Prize, and may result in the Prize being awarded to an alternate winner. If the Winner is disqualified, found to be ineligible, not in compliance with these Official Rules or declines to accept a prize, the Prize may be forfeited.
